OIL PIPELINE TARIFF FILING

Dear Ms. Bose:

In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 et seq. (“ICA”), and the Rules and Regulations of the Federal Energy Regulatory Commission (“Commission”), 18 C.F.R. § 341, Tesoro Logistics Northwest Pipelines LLC (“TLNP”) hereby submits for filing F.E.R.C. Nos. 6.0.0, 7.0.0, 8.0.0, 9.0.0, 10.0.0, 11.0.0 and 12.0.0 (the “Adoption Tariffs”) to be effective May 25, 2018, which is on less than one day’s notice.

In compliance with Section 341.6, 18 C.F.R. § 341.6, TLNP is filing the Adoption Tariffs to reflect TLNP’s acquisition of certain of the assets of Rocky Mountain Pipeline System LLC (“RMPS”) effective May 1, 2018. In this tariff filing, TLNP is adopting and making its own RMPS’ F.E.R.C. Tariff Nos. 171.10.1, 172.9.0, 175.12.0, 176.9.0, 184.13.0, 193.8.0 and 194.7.0, which TLNP is adopting through TLNP’s F.E.R.C. Nos. 6.0.0, 7.0.0, 8.0.0, 9.0.0, 10.0.0, 11.0.0 and 12.0.0.

TLNP therefore files the following Adoption Tariffs with an issue date of May 25, 2018 to be effective on May 25, 2018:

- TLNP F.E.R.C. No. 6.0.0 adopts RMPS F.E.R.C. No. 171.10.1 (IS18-259-000);
- TLNP F.E.R.C. No. 7.0.0 adopts RMPS F.E.R.C. No. 172.9.0 (IS17-300-000);
- TLNP F.E.R.C. No. 8.0.0 adopts RMPS F.E.R.C. No. 175.12.0 (IS17-300-000);
- TLNP F.E.R.C. No. 9.0.0 adopts RMPS F.E.R.C. No. 176.9.0 (IS17-300-000);
- TLNP F.E.R.C. No. 10.0.0 adopts RMPS F.E.R.C. No. 184.13.0 (IS17-300-000);
- TLNP F.E.R.C. No. 11.0.0 adopts RMPS F.E.R.C. No. 193.9.0 (IS17-300-000); and
- TLNP F.E.R.C. No. 12.0.0 adopts RMPS F.E.R.C. No. 194.7.0 (IS17-300-000).

TLNP has made the following changes to all of the Adoption Tariffs as part of the adoption process:

1. On the cover page, added “F.E.R.C. ICA Oil Tariff” in the upper left corner; changed the carrier name from “Rocky Mountain Pipeline System LLC” to “Tesoro Logistics Northwest Pipelines LLC”; added the pipeline name “SLC Core Pipeline” to the cover page; added filing authority language and an explanation of the tariff adoption; and canceled filing authority language related to a prior filing.
2. On the cover page, update the contact information in the “Issued By” and “Compiled By” sections;
3. On all pages after the first page, added a header to reflect the carrier name;
4. Changed references to Rocky Mountain Pipeline System LLC’s rules and regulations tariff to TLNP SLC Core Pipeline’s” rules and regulations tariff; and
5. Made formatting changes to improve the readability of the tariffs.

With respect to TLNP’s F.E.R.C. No. 6.0.0, TLNP has adopted the rules and regulations unchanged from RMPS’ F.E.R.C. No. 171.10.1 with the following exceptions:

1. On Page 2, cancelled the Table of Contents reference to “Gravity Bank Adjustments” to reflect the fact that the Gravity Bank Adjustment portion was not brought forward to TLNP F.E.R.C. Tariff No. 6.0.0 from RMPS’ F.E.R.C. Tariff No. 171.10.1.
2. On Page 4, changed the definition for Carrier to “Tesoro Logistics Northwest Pipelines LLC SLC Core Pipeline”;
3. On Page 10, cancelled Item 100 “Gravity Bank Adjustment.” Item 110 of RMPS’ F.E.R.C. Tariff No. 171.10.1 was not brought forward to TLNP F.E.R.C. Tariff No. 6.0.0 because the assets that TLNP acquired from RMPS were not parts of the RMPS system to which the Gravity Bank applied.
4. On Page 16, changed the reference to “Rocky Mountain Pipeline System LLC” to “Tesoro Logistics Northwest Pipelines LLC”; and
5. On Page 16, cancelled Items 110(1)(3)(4) and (5) to reflect to reflect the fact that those provisions of Item 110 were not brought forward to TLNP F.E.R.C. Tariff No. 6.0.0 from RMPS’ F.E.R.C. Tariff No. 171.10.1. Items 110(1)(3)(4) and (5) of RMPS’ F.E.R.C. Tariff No. 171.10.1 contained references to individual prorationing policies to specific segments of the RMPS system. The assets that TLNP acquired from RMPS did not include the segments subject to the individual prorationing policies listed in Items 110(1)(3)(4) and (5) were therefore not brought forward to TLNP F.E.R.C. Tariff No. 6.0.0.

TLNP notes that Item 20 “Tenders” has been brought forward unchanged from RMPS F.E.R.C. No. 171.10.1 because RMPS will continue to accept Nominations for transportation on the SLC Core Pipeline on behalf of TLNP. Shippers should therefore continue to tender Nominations in accordance with the provisions of Item 20.

TLNP emphasizes that no changes have been made to the rates and associated rules and regulations, including Notes and Exceptions, applicable to the transportation services contained in the Adoption Tariffs. No rates have been changed in the Adoption Tariffs and any rules that were changed or not brought forward were rules and regulations not applicable to transportation services.

TLNP F.E.R.C. No. 10.0.0 is a joint tariff with Andeavor Gathering I LLC. TLNP and Andeavor Gathering I concur in the Joint filing. Andeavor Gathering I can be contacted at:
