(2) INCENTIVE RATE TARIFF- Any Shipper that ships 25,000 barrels per day from State Line Station to Centurion Pipeline L.P., the RIO Midland Delivery Facility or Plains Pipeline, L.P. Midland South Terminal in a given month will be eligible to ship up to 25,000 barrels per day incremental to the initial 25,000 barrels per day at a rate of [U] 67.87 cents per barrel. For Committed Shippers, this incentive shall apply only after the Committed Shipper has shipped any prior month’s deficiency at the Shipper’s Committed Rate.

**OTHER CHARGES**

Gathering Charge: No gathering services will be performed under this rate tariff. The rates shown herein apply to trunk line transportation only.

Pumpover Fee: A pumpover fee of [U] 10.44 cents per barrel shall be assessed for volumes redelivered to a pipeline interconnected at an intermediate point.

Unloading Charge: All shipments received from tank truck unloading facilities provided by Andeavor Logistics RIO Pipeline, LLC or others, which deliver into Andeavor Logistics RIO Pipeline, LLC trunkline facilities, will be subject to a charge of [U] 15.69 cents per barrel.
