**APPLICATION OF RATES FROM INTERMEDIATE POINTS:** Rates from any origin not specified above to Mandan, North Dakota shall be the rate indicated for the North Dakota Station listed above that is the closest geographic point on the pipeline to the unspecified origin.

**Pumpover Fee:** When shipments are transferred from tank or truck facilities into the main line facilities of Tesoro High Plains Pipeline Company LLC, a charge of [I] 20.39 cents per barrel will be made in addition to the transportation rate stated above.

A [U] \$0.10 per Barrel charge for electric power will apply to all deliveries at the following origination points: In T146N 93W: Section 11 SESW, Section 13 NWNW, Section 24 SWSW, Section 25 NWNW, and also the following locations in T145N 93W: Section 10 SWSE, Section 12 SWSW, Section 13 NWNW, and Section 15 NENW and also the following locations in T146N 92W: Section 19 SWSE, Section 30 NENW.

\*The Gathering Rate for the Movement from Chimney Butte to Connolly Station is [I] 112.10 cents per Barrel. The Gathering Rate for movement on the Corral Creek Gathering System (points of origin upstream of Chimney Butte, for delivery into the Gathering System at Chimney Butte) for up to 3,200 Barrels per day (“bpd”) is [I] 37.17 cents per Barrel and the volume incentive rate for volumes greater than 3,200 bpd is [I] 33.69 cents per Barrel.

\*\*Effective September 9, 2017 a surcharge of [I] 5.56 cents per Barrel will be applied to all deliveries to Mandan, Morton County, ND.

\*\*\*Deliveries at Little Knife, Dunn County, ND for transportation to Mandan, Morton County, ND with H2S above 10 ppm shall incur a truck H2S high unloading fee of [I] 15.65 cents per Barrel.

~~[C] \*\*\*\*Transportation fees to this destination are waived because the crude petroleum moved to this destination is being used to test pipeline integrity. This temporary intrastate destination point will expire on August 1, 2018, or the day after the pigging of the line is completed, whichever is sooner. No other crude petroleum will be moved to this destination.~~
